## BAC RESOLUTION

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE CONDUCT OF THE OFFICE OF THE REGIONAL DIRECTOR (ORD) PROGRAM IMPLEMENTATION REVIEW (PIR) AND DIVISION PROCESS REVIEW (DPR) TO CIUDAD CHRISTHIA RESORT, INC.

Regional Office IV-A CALABARZON has undertaken WHEREAS, DepEd procurement of FOOD AND ACCOMMODATION for the CONDUCT OF THE OFFICE OF THE REGIONAL DIRECTOR (ORD) PROGRAM IMPLEMENTATION REVIEW (PIR) AND DIVISION PROCESS REVIEW (DPR) ON JUNE 27-28, 2022;

WHEREAS, the Approved Budget for the Contract (ABC) is FORTY THOUSAND PESOS (Php40,000.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise knonw as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative methods of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office starting on May 31, 2022 to June 6, 2022 at 9:00 a.m.

WHEREAS, RFQs were sent to at least three(3) prospective suppliers;

WHEREAS, one (1) supplier submitted its proposal; CIUDAD CHRISTHIA RESORT, INC. in the amount of FORTY THOUSAND PESOS (Php40,000.00). Thus, CIUDAD CHRISTHIA RESORT, INC. is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, CIUDAD CHRISTHIA RESORT, INC. complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);

NOW, THEREFORE, the BAC hereby RESOLVES as it hereby RESOLVED to RECOMMEND to the Regional Director, as the Head of the Procuring Entity, the award of the project to CIUDAD CHRISTHIA RESORT, INC. in the amount of FORTY THOUSAND PESOS (Php40,000.00).
