BAC RESOLUTION

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE DESIGNING AND DEVELOPMENT OF LEARNING RESOURCE PACKAGE (LPRs) FOR COMPETENCY ENHANCEMENT TRAINING OF REGIONAL OFFICE EMPLOYEES (CENTRE 1 AND 2) TO SUNRISE RIDGE CORPORATION (SOLESTE SUITES)

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **DESIGNING AND DEVELOPMENT OF LEARNING RESOURCE PACKAGE (LPRs) FOR COMPETENCY ENHANCEMENT TRAINING OF REGIONAL OFFICE EMPLOYEES (CENTRE 1 AND 2) ON JUNE 20-24, 2022;**

WHEREAS, the Approved Budget for the Contract (ABC) is **ONE HUNDRED SIXTY SIX THOUSAND PESOS (Php166,000.00);**

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative methods of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office starting on June 8, 2022 to June 13, 2022 at 9:00 a.m.

WHEREAS, RFQs were sent to at least three(3) prospective suppliers;

WHEREAS, one (1) supplier submitted its proposal; **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** in the amount of **ONE HUNDRED SIXTY FIVE THOUSAND ONE HUNDRED SEVENTY PESOS (Php165,170.00)**. Thus **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRIB);


