## BAC RESOLUTION

**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE MULTI HAZARD CONTINGENY PLANNING WORKSHOP TO CIUDAD CHRISTHIA RESORT, INC.**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **MULTI HAZARD CONTINGENY PLANNING WORKSHOP ON JULY 18-22, 2022**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **TWO HUNDRED SIXTY TWO THOUSAND PESOS (Php262,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise know as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative methods of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) website, office website and conspicuous bulletin board in the premises of this Office starting on June 29, 2022 to July 4, 2022 at 9:00 a.m.

**WHEREAS**, RFQs were sent to at least three (3) prospective suppliers;

**WHEREAS**, two (2) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:

**WHEREAS**, upon evaluation or careful examination of the technical specification submitted by **CALIRAYA RESORT CLUB, INC.**, the BAC found that it was ineligible because its quotation does not comply with the specification (location) issued by this Office.
