#### CONTRACT OF SERVICE

KNOW ALL MEN BY THESE PRESENTS:

This contract made and entered into by and between:

**DEPARTMENT OF EDUCATION, Region IV-A**, a government agency with office address at Gate 2 Karangalan Village, Cainta, Rizal, represented by its Regional Director, **FRANCIS CESAR B. BRINGAS**, hereinafter referred to as the **CLIENT**.

-and-

**TAGAYTAY COUNTRY HOTEL**, with principal address at Emilio Aguinaldo Highway, Olivarez Plaza, Tagaytay City, Cavite, represented herein by its Sales Account Executive, **KING VECINAL DUENAS**, hereinafter referred to as the **HOTEL COMPANY**.

#### WITNESSETH

WHEREAS, the CLIENT needs the services of a contractor who will provide food and hotel accommodation to the participants in the "CAPACITY BUILDING CUM WORKSHOP FOR SDO M&E FOCAL PERSONS ON DEVELOPING MONITORING AND EVALUATION TOOLS FOR DIFFERENT PPAS" on June 16-17, 2022.

WHEREAS, the Approved Budget for the Contract (ABC) is ONE HUNDRED THIRTY-SIX THOUSAND PESOS ONLY (Php136,000.00);

**WHEREAS**, Rule XVI, Section 48.2 of the IRR of RA 9184 provides the general rule that public bidding is the general mode of procurement. However, the same section allows procuring entities to resort to alternative methods of procurement such as Negotiated Procurement subject to the approval of the Head of the Procuring Entity;

**WHEREAS,** Rule XVI, Section 53.9 of the IRR of RA 9184 allows Negotiated Procurement under Small Value Procurement as a mode of procurement subject to the approval of the Head of the Procuring Entity;

**WHEREAS**, the Request for Quotation (RFQ) was posted at the website of PhilGEPS, office website and conspicuous bulletin board of the regional office on May 30, 2022 to June 6, 2022;

**WHEREAS**, RFQs were sent to at least three prospective suppliers;

**WHEREAS**, two (2) Suppliers submitted their respective proposal before the deadline for the submission of bids, offering the following financial bids, as read:

WHEREAS, after review and deliberation on proposal of the lowest read bidder, the BAC found the bidder compliant and responsive to the technical and financial requirements of the procurement activity hence, subsequently declared TAGAYTAY COUNTRY HOTEL, as the Lowest Calculated and Responsive Bidder (LCRB);

WHEREAS, under the latest resolution and guidelines of the Inter-Agency Task Force on Emerging Infectious Diseases (IATF-EID) issued on October 18, 2021, the Certificate of Authority to Operate and Safety Seal Certificate issued by the Department of Tourism (DOT) applies in areas classified under General Community Quarantine (GCQ), GCQ with Heightened Restriction (GCQ-HR), or Alert Level 4 and Alert Level 3.

WHEREAS, TAGAYTAY COUNTRY HOTEL. is within Tagaytay City, Cavite under Alert Level 1.

WHEREAS, the Entity invited Bids for the Procurement for the hotel accommodation of the participants in the "CAPACITY BUILDING CUM WORKSHOP FOR SDO M&E FOCAL PERSONS ON DEVELOPING MONITORING AND EVALUATION TOOLS FOR DIFFERENT PPAS" which will be held on June 16-17, 2022 and has accepted a Bid by the Hotel Company for food and hotel accommodation in the sum of One Hundred Thirty-Two Thousand Six Hundred Pesos Only (Php132,600.00). (Hereinafter called "the Contract Price").

**NOW, THEREFORE,** for and in consideration of the foregoing premises of the mutual covenants and provisions hereafter set forth the parties hereto have agreed and do hereby mutually agree as follows:

# Section 1 Responsibilities of the Hotel Company

The Hotel Company shall:

- 1. Provide food and hotel accommodation on June 16-17, 2022 to the Thirty-Four (34) participants of the client;
- 2. Maintain that all of the services to be performed under or pursuant to this contract shall be of the standard and quality which prevail among similar businesses and organizations of superior knowledge and skill engaged in providing similar services under the same or similar circumstances.

# Section 2 Responsibilities of the Client

The Client will pay the Hotel Company the guaranteed number of participants. The Client shall be charged or billed the amount of One Thousand Nine Hundred Fifty Pesos Only (**Php1,950.00**) per day, per participant for the June 16-17, 2022, or the total amount of One Hundred Thirty-Two Thousand Six Hundred Pesos Only (**Php132,600.00**) for the whole duration of the event.

# Section 3 Supervision and Control

The Hotel Company shall exercise strict discipline, close supervision and exclusive control and administration over its personnel in accordance with law, ordinances and pertinent government rules and regulations as well as the rules and policies laid down by the CLIENT on the matter. In so far as enforcement of police, and company rules and regulations related to softty in

concerned, the CLIENT shall exercise supervision and control over the participants.

### Section 4 Liability to Personnel and Third Parties

The Hotel Company is NOT an agent or employee of the CLIENT and the personnel to be assigned by the Hotel Company to the CLIENT are in no sense employees of the latter as they are for all intents and purposes employees of the Hotel Company.

Accordingly, the CLIENT shall not be responsible for any all claims for personal injury caused to any of the personnel or to any third party where such injury arises out of or in the course of performance of said personnel.

# Section 5 **Hotel Accommodation Inclusions**

In addition to the services offered mentioned above, the Hotel Company shall provide for the following inclusions:

#### a. Food

-Breakfast, AM Snack, PM Snack and Dinner (DAY ONE (1): First meal to be served is breakfast and LAST DAY: Last meal to be served is PM snack with attached menu options

#### b. Hotel Accommodation

-Air conditioned, with TV and Hot and Cold Shower.

-3 to 4 persons per room, depend on the size of the room and ALERT LEVEL from the IATF Guidelines (in compliance with social distancing protocol)

#### c. Function Hall

-Use of Air-conditioned Function Hall

-5 to 7 persons for big round table depending the size to observe (social distancing)

-big halls good to observe social distancing

-with good lighting and ventilation

- d. Multi Media Projector with Wide Screen
- e. STABLE and STRONG Internet Connection in the CONFERENCE ROOM and ROOM OF THE PARTICIPANTS
- f. Extension Cords
- g. Whiteboard
- h. Sound System and Microphone
- i. Brewed coffee during session

# Section 6 Use of Hotel Parking Space

The Hotel Company shall allow the use of its parking space to the workshop participants free of charge.

### Section 7 Assignment

This contract cannot be assigned by either party. In case assignment will be made, the party assigning must inform the other party of such arrangement at least one day prior to the activity.

# Section 8 Termination of Contract

Either party may terminate this contract on any ground provided by law and for violation/s of the provisions of this contract. In such case, the party terminating shall serve a written notice to the other party at least one (1) day prior to the effectivity of termination.

# Section 9 Venue of Action

In case an action will arise from this agreement, the venue of the action shall be in Taytay, Rizal or Pasig City only.

# Section 10 Warranty

The Hotel Company hereby warrants and attest that the signatory in this contract is duly authorized by the Board and / or its Management to sign for and its behalf.

# Section 11 Other conditions of the contract

The Hotel Company shall cause the notarization of this contract.
