

With reference to Regional Memorandum No. 414, s. 2022 on the conduct of Regional Training of Trainers (RToT) for Master Teachers Professional Development Program 2.0 (MTPDP 2.0) on July 18-23, 2022 for Batch 1 and August 8-13, 2022 for Batch 2 at National Educators' Academy of the Philippines in the Region (NEAP-R) Training Facility, Malvar, Batangas, this Office, through the Human Resource Development Division NEAP-R, disseminates the following clarificatory provisions:
  - Non-teaching and teaching-related participants, learning facilitators, class managers, and members of Program Management Team shall be entitled to a Compensatory Time Off (CTO) as per Civil Service Commission (CSC) and Department of Budget Management (DBM) Joint Circular No. 2, s. 2004 on Non-Monetary Renumeration for Overtime Service Rendered on July 23, 2022 (Saturday) for Batch 1 and August 13, 2022 (Saturday) for Batch 2.
  - **Teacher-participants and learning facilitators** shall be given service credits as per DepEd Order No. 53, s. 2003 titled "Updated Guidelines on Grant of Vacation Service Credits to Teachers" for their participation from July 18 to 23, 2022 for Batch 1 and from August 8 to 13, 2022 for Batch 2.
