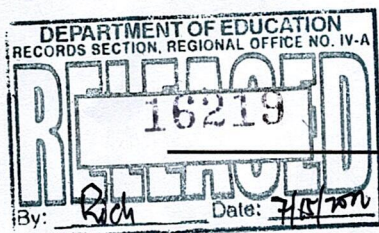



SYSTEM MEMBERS FOR FY 2022**

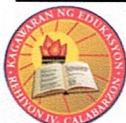
To
