## DANCESPORT LIMITED FACE-TO-FACE REGIONAL COMPETITION

#### To: Schools Division Superintendents

- With reference to Memorandum dated June 15, 2022, issued by the Office of Joel S. Erestain, Director III, Palarong Pambansa Secretariat regarding National Dance Sport Championship 2022 Palarong Pambansa Limited Faceto-Face Competition, this Office shall hold the Dance Sport Limited Face-to-Face Regional Competition on July 14, 2022, at the Event Center, SM City, Lucena City.
- 2. The Chairpersons of the Screening and Accreditation Committee of the concerned divisions are advised to submit the soft copies of the required documents on or before July 12, 2022, at the link to be provided to them. Hard copies of the required documents will be submitted to the Regional Screening Committee by the coach on the day of the competition. The Members of the Regional Screening Committee are directed to be at the designated Regional Screening Headquarters from July 13-14, 2022.
- 3. All concerned are to provide the necessary support and assistance to the participating student-athletes, including DepEd personnel who will serve as coaches, chaperon, technical officials, and members of the various technical working committees.
- 4. Members of delegation including identified student-athletes must have their complete COVID 19 vaccines. They are advised to bring their vaccination card for verification and strictly follow the IATF Safety protocols.
- 5. DepEd personnel who will serve as technical officials and members of the various technical working committees and perform game-related administrative work shall secure an official travel authority. Proof of vaccination such as vaccination cards or DOH-issued vaccination certificates and a medical certificate must be presented to the Tournament Manager.
- 6. Guidelines on the conduct of the Dance sport Limited Face-to-Face Regional Competition, List of Participating Divisions and Members of the Different Working Committees and Technical Officials are attached for reference. (Enclosures 1, 2 & 3)
