SAFETY AND HEALTH**


To **School Division Superintendents**

1. The Department strengthens its capacity for the promotion of safety and health in the workplace through safety officer practitioners. Thus, the Department of Education Region IV-A CALABARZON through the Education Support Services Division will facilitate the **"Occupational Safety and Health Training"** on July 25-29, 2022 at a venue which will announced in a separate advisory.

6. Upon completion of the training program, certified safety officers shall render service to their respective offices relative to Health and Safety program.
