BAC RESOLUTION

DECLARING COSMIC TECH NOLOGIES INC. AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROCUREMENT OF TABLETS FOR KS2, KS3 AND KS4 FOR SCHOOL YEAR (SY) 2022-2023 (LOT I-ROIVA-22-01)

WHEREAS, on May 21, 2022, DepEd Regional Office IV-A CALABARZON has advertised its procurement activity for the **PROCUREMENT OF TABLETS FOR KS2, KS3 AND KS4 FOR SCHOOL YEAR 2022-2023 (LOT I-ROIVA-22-01)** in the PhilGEPS website, office website, and in conspicuous bulletin board of the office;

WHEREAS, on June 16, 2022, a post-qualification was conducted by Ms. Ann Geralyn T. Pelias, Chief-ASD and BAC Vice-Chairperson and Mr. Rey Valenzuela, Information Technology Officer to Arik General Merchandizing being the lowest bidder;

WHEREAS, a report was submitted to the BAC, the BAC issued a Resolution No. BR01-150 series of 2022 declaring the post-disqualification of Arik General Merchandizing and recommending the post-qualification of Cosmic Tech Nologies Inc. as the Second Lowest Calculated Bidder;

WHEREAS, on June 28, 2022, Ms. Cherrylou D. Repia, Assistant Regional Director and BAC Chairperson issued a Notice of Post-Disqualification to Arik General Merchandizing;

WHEREAS, on July 5, 2022, Arik General Merchandizing filed a Motion for Reconsideration praying that the post-disqualification be reconsidered, set aside and a resolution be issued declaring Arik General Merchandizing to have passed the post-qualification;

WHEREAS, on July 7, 2022, the BAC conducted a meeting for the evaluation, review and discussion of the motion for reconsideration of Arik General Merchandizing;

WHEREAS, on July 11, 2022, the BAC conducted another meeting for the finalization and approval of the Resolution denying the motion for reconsideration of Arik General Merchandizing;

WHEREAS, on the same day, the BAC thru its BAC Secretariat sent the Resolution via email to Arik General Merchandising. On July 13, 2022, the hard copy of the resolution was likewise sent via LBC;

WHEREAS, on July 19, 2022, a post-qualification was conducted on Cosmic Tech Nologies Inc. being the second lowest bidder;

- b. There exist a Google MADA agreement between Cosmic Tech Nologies and Google LLC.
- c. An online check of the ISO certification of manufacturer reveal that the said certification was issued to Shenzhen Tengzhi Communication Technology Co., Ltd. with address at Room 501, 5/F Building B, Huafeng International Robotics Industrial Park, Hangcheng Avenue, Nanchang Community, Xixiang Subdistrict, Bao'an District, Shenzhen.
- d. All the submitted documents during the bid opening had been verified and validated against the originals; and
- e. Brief inspection of the tablet offered for Lot I reveal that it is compliant with the specifications set by the office.


NOW, THEREFORE, the BAC hereby **RESOLVES**, as it hereby **RESOLVED**:
