**RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF
CONTRACT FOR THE PROCUREMENT OF CATERING SERVICES FOR THE
PREPARATORY WORKSHOP FOR THE FY 2022 SECOND QUARTER PROGRAM
IMPLEMENTATION REVIEW (PIR) TO ROSHER'S CATERING SERVICES**

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **PREPARATORY WORKSHOP FOR THE FY 2022 SECOND QUARTER PROGRAM IMPLEMENTATION REVIEW (PIR) ON JULY 11, 2022;**

WHEREAS, the Approved Budget for the Contract (ABC) is **NINE THOUSAND SIX HUNDRED PESOS (Php9,600.00);**

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative methods of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office starting on July 2, 2022 to July 6, 2022 at 9:00 a.m.

WHEREAS, RFQs were sent to at least three (3) prospective suppliers;

WHEREAS, one (1) Supplier submitted its proposal; **ROSHER'S CATERING SERVICES** in the amount of **NINE THOUSAND SIX HUNDRED PESOS (Php9,600.00)**. Thus, **ROSHER'S CATERING SERVICES** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **ROSHER'S CATERING SERVICES** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **ROSHER'S CATERING SERVICES** in the amount of **NINE THOUSAND SIX HUNDRED PESOS (Php9,600.00)**.






