**REQUEST FOR SUBMISSION OF STATUS OF UNFILLED
 TEACHING POSITIONS FOR SY 2022-2023**

To **Schools Division Superintendent**
All others concerned

1. Per DepEd Order No. 34, s. 2022, the department has opened the school year 2022-2023 last August 22, 2022. To date, around 95% of the expected 3.3 million learners in the public schools has already enrolled in the basic education system in the region. Given the increasing enrollment, the region has estimated a shortage of around twenty-three thousand (23,000) teaching positions in all levels to meet the ideal class size.
2. To address this concern, the Department regularly allocates new teaching positions to schools needing the same to improve the ratio of learners to teachers, enhance learning, and ease workload of personnel in public schools through the Basic Education Inputs Program.
3. Relevant to this, the Regional Office would like to inform you of the summary of unfilled positions:
