BAC RESOLUTION

**RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF
CONTRACT TO L & B INTERNATIONAL TOURIST HOTEL (CAMELOT HOTEL)
FOR THE PROCUREMENT OF LEASE OF VENUE WITH MEALS FOR THE
COORDINATION MEETING WITH CALABARZON DISTRICT REPRESENTATIVE
IN THE CONGRESS**

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **LEASE OF VENUE WITH MEALS** for the **COORDINATION MEETING WITH CALABARZON DISTRICT REPRESENTATIVE IN THE CONGRESS ON AUGUST 30, 2022**;

WHEREAS, the Approved Budget for the Contract (ABC) is **ONE HUNDRED FORTY FIVE THOUSAND TWO HUNDRED PESOS (Php145,200.00)**;

WHEREAS, Rule XVI, Section 48.2 of the IRR of RA 9184 provides the general rule that public bidding is the general mode of procurement. However, the same section allows procuring entities to resort to alternative methods of procurement such as Negotiated Procurement subject to the approval of the Head of Procuring Entity;

WHEREAS, Rule XVI, Section 53.10 of the IRR of RA 9184 allows Negotiated Procurement under Lease of Real Property and Venue as a mode of procurement subject to the approval of the Head of Procuring Entity;

WHEREAS, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office starting on August 18, 2022 to August 23, 2022 at 9:00 a.m.;

WHEREAS, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to three (3) prospective suppliers. The three (3) prospective suppliers are as follows: (1) SEAMEO INNOTECH; (2) MICROTEL; and (3) L & B INTERNATIONAL TOURIST HOTEL (CAMELOT HOTEL);

WHEREAS, one (1) suppliers submitted its proposal; **L & B INTERNATIONAL TOURIST HOTEL (CAMELOT HOTEL)** in the amount of **ONE HUNDRED THIRTY THREE THOUSAND ONE HUNDRED PESOS (Php133,100.00)**. Thus, **L & B INTERNATIONAL TOURIST HOTEL (CAMELOT HOTEL)** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **L & B INTERNATIONAL TOURIST HOTEL (CAMELOT HOTEL)** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);

WHEREAS, the end-user conducted an ocular inspection to **L & B INTERNATIONAL TOURIST HOTEL (CAMELOT HOTEL)** and rated in accordance with the technical


