## BAC RESOLUTION

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the TRAINING-WORKSHOP ON THE DEVELOPMENT OF SUCCESSION AND EXIT PROGRAM ON AUGUST 8-10, 2022;

**WHEREAS,** the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) website, office website and conspicuous bulletin board in the premises of this Office starting on July 13, 2022 to July 18, 2022 at 9:00 a.m.
