

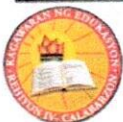
NATIONAL ROLLOUT OF COMPREHENSIVE SEXUALITY EDUCATION (CSE) INTEGRATION IN THE CURRICULUM

To **Schools Division Superintendents**

1. In reference with DM-CI-2022-294, the Bureau of Curriculum Development (BCD) in coordination with the United Nations Population Fund (UNFPA), Center for Health Solutions and Innovations Philippines, Inc. (CHSI) and Commission on Population (POPCOM), shall conduct a **NATIONAL ROLLOUT OF COMPREHENSIVE SEXUALITY EDUCATION (CSE) INTEGRATION IN THE CURRICULUM** through a national and regional workshop on September 26-30, 2022 via Zoom and FB livestream.
2. The objectives of the activity are:
 - a. Provide technical updates on CSE integration in the K to 12 curriculum;
 - b. Foster collaboration between and among program managers and implementers to intensify support for the implementation of CSE; and
