**WHEREAS**, three (3) Suppliers submitted their respective proposals before the deadline for submission of bids, offering the following financial bids, as read:

**WHEREAS**, upon evaluation or careful examination of the technical specification submitted by **MYDIVE TRAVEL AND TOURS INC.**, the BAC found that it was ineligible because its quotation does not comply with the specification issued by this Office

**WHEREAS**, after review and deliberation on the proposal, the **Hotel Company** complied with the requirements and declared as the Lowest Calculated and Responsive Bid (LCRB);

**WHEREAS**, under the latest resolution and guidelines of the Inter-Agency Task Force on Emerging Infectious Diseases (IATF-EID) issued on October 18, 2021, the Certificate of Authority to Operate and Safety Seal **Certificate issued by the Department of Tourism (DOT) applies in areas classified under General Community Quarantine (GCQ), GCQ with Heightened Restriction (GCQ-HR), or Alert Level 4 and Alert Level 3.**

**WHEREAS**, **Hotel Company** is within Las Pinas under Alert Level 1.

**WHEREAS**, the Entity invited Bids for the Procurement for the hotel accommodation of the participants in the **"FY 2021 NQESH POST EVALUATION ACTIVITY"** on **September 21-23, 2022** and has accepted a Bid of **FY 2021 NQESH POST EVALUATION ACTIVITY** for food and hotel accommodation in the sum of **FIVE HUNDRED FOUR THOUSAND PESOS ONLY (Php504,000.00)**. (Hereinafter called "the Contract Price").

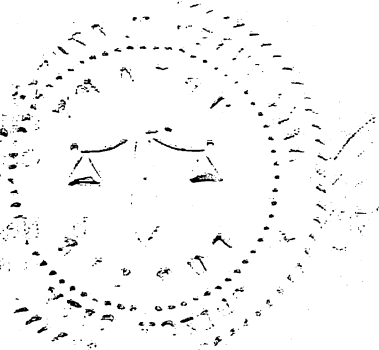
