BAC RESOLUTION

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO SUNRISE RIDGE CORPORATION (SOLESTE SUITES) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE CONDUCT OF THE OFFICE OF THE REGIONAL DIRECTOR (ORD PROGRAM IMPLEMENTATION REVIEW (PIR) AND DIVISION PROCESS REVIEW (DPR)

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **CONDUCT OF THE OFFICE OF THE REGIONAL DIRECTOR (ORD PROGRAM IMPLEMENTATION REVIEW (PIR) AND DIVISION PROCESS REVIEW (DPR)** on **SEPTEMBER 29-30, 2022;**

WHEREAS, the Approved Budget for the Contract (ABC) is **SIXTY THOUSAND PESOS (Php60,000.00);**

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative methods of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) website, office website and conspicuous bulletin board in the premises of this Office starting on September 16, 2022 to September 21, 2022 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) THE FIRST VILLA CRISTINA HOTEL & RESORT INC.; (2) CIUDAD CHRISTHIA RESORT; and (3) GEMS HOTEL ANTIPOLLO;

WHEREAS, one (1) Supplier submitted its proposal; **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** in the amount of **FIFTY NINE THOUSAND EIGHT HUNDRED FIFTY PESOS (Php59,850.00)**. Thus, **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** in the




