## **BAC RESOLUTION**

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO M.I. SEVILLA RESORT FOR THE FOOD AND ACCOMMODATION FOR THE MASS TRAINING OF ALS TEACHERS ON THE IMPLEMENTATION OF ALS ACT AND ITS IMPLEMENTING RULES AND REGULATIONS (IRR) (BATCH 4)

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION FOR THE MASS TRAINING OF ALS TEACHERS ON THE IMPLEMENTATION OF ALS ACT AND ITS IMPLEMENTING RULES AND REGULATIONS (IRR) (BATCH 4) ON SEPTEMBER 1-2, 2022;

WHEREAS, the Approved Budget for the Contract (ABC) is NINE HUNDRED TWENTY FOUR THOUSAND PESOS (Php924,000.00);

**WHEREAS,** Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative methods of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS,** the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) website, office website and conspicuous bulletin board in the premises of this Office starting on August 16, 2022 to August 22, 2022 at 9:00 a.m.

**WHEREAS,** RFQs were sent to at least three (3) prospective suppliers;

WHEREAS, one (1) Supplier submitted its proposal; M.I. SEVILLA RESORT in the amount of EIGHT HUNDRED THIRTY ONE THOUSAND SIX HUNDRED PESOS (Php831,600.00). Thus, M.I. SEVILLA RESORT is declared as the lone bidder;

**WHEREAS,** after review and deliberation on the proposal, **M.I. SEVILLA RESORT** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **M.I. SEVILLA RESORT** in the amount of **EIGHT HUNDRED THIRTY ONE THOUSAND SIX HUNDRED PESOS (Php831,600.00)**.
