RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO MARAWI LEISURE PARK INC. (TANZA OASIS HOTEL AND RESORT) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE ORIENTATION ON PROPERTY AND SUPPLY MANAGEMENT SYSTEM

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the ORIENTATION ON PROPERTY AND SUPPLY MANAGEMENT SYSTEM on OCTOBER 24-27, 2022;

WHEREAS, the Approved Budget for the Contract (ABC) is EIGHT HUNDRED SIXTY-FOUR THOUSAND PESOS (Php864,000.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative methods of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) website, office website and conspicuous bulletin board in the premises of this Office starting on September 20, 2022 to September 26, 2022 at 9:00 a.m.

WHEREAS, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) VILLA EXCELLANCE BEACH AND WAVE POOL RESORT; (2) THE BAYLEAF - CAVITE; and (3) TANZA OASIS HOTEL AND RESORT;

WHEREAS, five (5) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:
