**BAC RESOLUTION**

**RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF  
CONTRACT TO CALIV RESORT AND DEVELOPMENT CORP. (VILLA  
EXCELLANCE BEACH AND WAVE POOL RESORT) FOR THE PROCUREMENT  
OF FOOD AND ACCOMMODATION FOR THE RO & SDO CONVERGENCE FOR  
THE LEARNING RECOVERY & CONTINUITY PLAN**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **RO & SDO CONVERGENCE FOR THE LEARNING RECOVERY & CONTINUITY PLAN ON SEPTEMBER 21-23, 2022**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **FOUR HUNDRED TWENTY THOUSAND PESOS (Php420,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative methods of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) website, office website and conspicuous bulletin board in the premises of this Office starting on September 15, 2022 to September 19, 2022 at 9:00 a.m.;

**WHEREAS**, RFQs were sent to at least four (4) prospective suppliers. The four (4) prospective suppliers are as follows: (1) Villa Excellance Beach and Wave Pool Resort; (2) The Bayleaf – Cavite; (3) El Cielito Hotel; and (4) Ciudad Christhia Resort, Inc.;

**WHEREAS**, four (4) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:

**WHEREAS**, upon evaluation or careful examination of the technical specification submitted by **LA SUEÑA BRISA BEACH RESORT AND EVENT PLACE**, the BAC found that it was ineligible because its quotation does not comply with the specifications issued by this Office.

**WHEREAS**, after review and deliberation on the proposal of **SUNNY GLADES PROPERTIES CORP. (DEMETER ESCAPADE EVENTS PLACE)**, the BAC found that it was non-responsive based on the evaluation submitted by the HRDD-NEAPR headed by Ms. Luz E. Osmeña because of poor and weak internet connectivity, the venue is not conducive and not accessible to the participants (attached is the Activity Completion Report);

**WHEREAS**, after review and deliberation on the proposal, **CALIV RESORT AND DEVELOPMENT CORP. (VILLA EXCELLANCE BEACH AND WAVE POOL RESORT)** complied with the requirements and declared as the Lowest Calculated and Responsive Bid (LCRB);


**NOW, THEREFORE**, the BAC hereby **RESOLVES**, as it hereby **RESOLVED**:


1. To **DECLARE LA SUEÑA BRISA BEACH RESORT AND EVENT PLACE** as ineligible bidder for failure to comply with the required specifications;
2. To **DECLARE SUNNY GLADES PROPERTIES CORP. (DEMETER ESCAPADE EVENTS PLACE)** as non-responsive bidder because of poor and weak internet connectivity, venue is not conducive and not accessible to the participants; and
3. To **RECOMMEND** to the Head of Procuring Entity the award of the project to **CALIV RESORT AND DEVELOPMENT CORP. (VILLA EXCELLANCE BEACH AND WAVE POOL RESORT)** in the amount of **THREE HUNDRED NINETY-NINE THOUSAND PESOS (Php399,000.00)**


