2022 PRIVATE SCHOOLS SUMMIT

- To **Schools Division Superintendents Division Private School Organization Presidents**
 - 1. In consonance with the mandates of the Quality Assurance Division (QAD) on Regulatory and Developmental Services to Schools and ensuring its optimum collaboration with the private schools, this Office announces the 2022 Private Schools Summit with the theme "Embracing the Diverse Challenges of Private Schools in CALABARZON through One Act, One Heart, and One Goal towards Collaborative Recovery" on October 20-21, 2022 at Extremeli Suites Manila, G-21 Solemare Parksuites 1701, Bradco Ave, Parañaque, Metro Manila.
 - 2. The said activity shall also be aired LIVE via Region IVA-CALABARZON Official YouTube channel to reach out to thousands of SDO personnel, private school administrators and teachers. An online registration shall be coursed through the respective SDOs.
- 3. This activity aims to provide a harmonious avenue to engage and collaborate with the private schools' administrators and teachers on the recent DepEd issuances, education trends, issues and concerns relevant to private school operations.
- 4. The onsite participants to this activity are the Private School's Organization Presidents, SDO Private School Coordinators and Planning Officers, Quality Assurance Division (QAD) Personnel, select PPRD personnel and Legal Officers. On the other hand, ICT personnel shall also be part of the activity to assist in technical concern. Please refer to Enclosure 1 for details.
- 5. Further, prior to the conduct of the private school summit, a virtual and in-depth focus group discussion shall be held to ensure that current issues and concerns of the private schools in the Region are identified and addressed accordingly. Thus, select private school coordinators, select presidents of private school organization and other key personnel shall participate. The results of such shall be utilized to add value to the summit. The FGD schedule and other details shall be communicated to the concern participants.
- 6. The first meal to be served is breakfast of Day 1 (October 20) and the last meal is afternoon snacks of Day 2 (October 21).
