## **BAC RESOLUTION**

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO GOD'S TREASURE ENTERPRISES FOR THE PROCUREMENT OF CATERING SERVICES FOR THE DEPED 4A FOR YOU SEASON 3 PRODUCTION

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of CATERING SERVICES for the DEPED 4A FOR YOU SEASON 3 PRODUCTION on OCTOBER 5, 12, 19, 26, NOVEMBER 9, 16, 23 AND DECEMBER 7, 2022;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **NINETY-SIX THOUSAND PESOS (Php96,000.00)**;

**WHEREAS,** Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative methods of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS,** the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office on September 29, 2022 to October 3, 2022 at 9:00 a.m.;

**WHEREAS,** RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) GOD'S TREASURE ENTERPRISES; (2) 7CS CATERING SERVICES; and (3) CHEF CHRYZ TINA CATERING;

WHEREAS, one (1) Supplier submitted its proposal; GOD'S TREASURE ENTERPRISES in the amount of NINETY-THREE THOUSAND SIX HUNDRED PESOS (Php93,600.00). Thus, GOD'S TREASURE ENTERPRISES is declared as the lone bidder;

**WHEREAS,** after review and deliberation on the proposal, **GOD'S TREASURE ENTERPRISES** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **GOD'S TREASURE ENTERPRISES** in the amount of **NINETY-THREE THOUSAND SIX HUNDRED PESOS (Php93,600.00)**.
