BAC RESOLUTION

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO GOD'S TREASURE ENTERPRISES FOR THE PROCUREMENT OF CATERING SERVICES FOR THE 2022 ANNUAL PHYSICAL AND LABORATORY EXAMINATION AND VACCINATION

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **2022 ANNUAL PHYSICAL AND LABORATORY EXAMINATION AND VACCINATION ON NOVEMBER 7, 11, 14 AND 18, 2022;**

WHEREAS, the Approved Budget for the Contract (ABC) is **NINETY-ONE THOUSAND EIGHT HUNDRED PESOS (Php91,800.00);**

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative methods of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

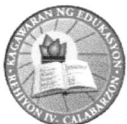
WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) website, office website and conspicuous bulletin board of the regional office on October 13, 2022 to October 18, 2022 at 9:00am;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers. The three (3) prospective suppliers are as follows: (1) God's Treasure Enterprises; (2) Rosher's Catering Services; and (3) Chef Chryz Tina Catering;

WHEREAS, one (1) supplier submitted its proposal; **GOD'S TREASURE ENTERPRISES** in the amount of **EIGHTY-EIGHT THOUSAND SEVEN HUNDRED FORTY PESOS (Php88,740.00)**. Thus, **GOD'S TREASURE ENTERPRISES** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **GOD'S TREASURE ENTERPRISES** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **GOD'S TREASURE ENTERPRISES** in the amount of **EIGHTY-EIGHT THOUSAND SEVEN HUNDRED FORTY PESOS (Php88,740.00)**.


