BAC RESOLUTION

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO BLOOMBOOKS INC. FOR THE PRINTING AND DELIVERY OF ALS LEARNING RESOURCES FOR THE IMPLEMENTATION OF BE-LCP (ROIVA-22-03)

WHEREAS, on September 6, 2022, DepEd Regional Office IV-A CALABARZON has advertised its procurement activity for the **PRINTING AND DELIVERY OF ALS LEARNING RESOURCES FOR THE IMPLEMENTATION OF BE-LCP (ROIVA-22-03)** in the Philippine Government Electronic Procurement System (PhilGEPS) website, office website, and in conspicuous bulletin board of the office;

WHEREAS, the Approved Budget for the Contract (ABC) is **SEVEN MILLION EIGHT HUNDRED FORTY-THREE THOUSAND SIX HUNDRED FORTY-FOUR PESOS (Php7,843,644.00)**;

WHEREAS, three (3) bidders submitted their bidding documents at the Regional Office; that during the Bid Opening, **BLOOMBOOKS INC., STA. BARBARA PRINTSHOP & GEN. MDSE.** and **HAUS OF SERAH PRINTING AND TRADING CORP.** presented their respective Bidding Documents for bid evaluation by the Bids and Awards Committee (BAC);

WHEREAS, using the checklist of required documents and taking into account the non-discretionary "Pass or Fail Criterion", the BAC determined that the three (3) bidders, **BLOOMBOOKS INC., STA. BARBARA PRINTSHOP & GEN. MDSE.** and **HAUS OF SERAH PRINTING AND TRADING CORP.** met the criterion and were initially rated as "Passed" or "Complying";

WHEREAS, per Abstract of Bids, the bidder who has the Lowest Calculated Bid (LCB) is **BLOOMBOOKS INC.** with a total bid of **TWO MILLION ONE HUNDRED TWENTY THOUSAND FORTY-THREE PESOS AND 40/100 (Php2,120,043.40)**, to wit:
