WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the CAPACITY BUILDING CUM WORKSHOP OF RO AND SDO ASSOCIATES FOR QATAME OF L&D ACTIVITIES on OCTOBER 25-27, 2022;

WHEREAS, the Approved Budget for the Contract (ABC) is **TWO HUNDRED SIXTY-FOUR THOUSAND PESOS (Php264,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative methods of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof:

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on October 7, 2022 to October 12, 2022 at 9:00 a.m.

WHEREAS, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) TAGAYTAY COUNTRY HOTEL; (2) CIUDAD CHRISTIA RESORT; and (3) FIRST STA. ROSA HOTEL CORP. EL CIELITO – STA. ROSA;
