**BAC RESOLUTION**

**RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO THE FIRST VILLA CRISTINA RESORT & HOTEL FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE HYBRID WRITESHOP ON THE DEVELOPMENT OF LESSON EXEMPLARS FOR ARTS AND CULTURE EDUCATION**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **HYBRID WRITESHOP ON THE DEVELOPMENT OF LESSON EXEMPLARS FOR ARTS AND CULTURE EDUCATION** on **NOVEMBER 7-11, 2022**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **ONE HUNDRED FORTY-FOUR THOUSAND PESOS (Php144,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative methods of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on October 27, 2022 to November 2, 2022 at 9:00 a.m.

**WHEREAS**, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) THE FIRST VILLA CRISTINA RESORT & HOTEL; (2) CLOUD 9 ANTIPOLO; and (3) FIRST PHILIPPINE REALTY CORPORATION (EUGENIO LOPEZ CENTER);

**WHEREAS**, one (1) Supplier submitted its proposal; **THE FIRST VILLA CRISTINA RESORT & HOTEL** in the amount of **ONE HUNDRED FORTY-FOUR THOUSAND PESOS (Php144,000.00)**. Thus, **THE FIRST VILLA CRISTINA RESORT & HOTEL** is declared as the lone bidder;

**WHEREAS**, after review and deliberation on the proposal, **THE FIRST VILLA CRISTINA RESORT & HOTEL** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);


