RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO M.I. SEVILLA RESORT FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE FINALIZATION WORKSHOP ON THE REGIONAL GUIDELINES OF REACH, READ, AND RISE (3R's) PROGRAM THROUGH ELLN AND 3B's INITIATIVE

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the FINALIZATION WORKSHOP ON THE REGIONAL GUIDELINES OF REACH, READ, AND RISE (3R's) PROGRAM THROUGH ELLN AND 3B'S INITIATIVE on SEPTEMBER 28-30, 2022;

WHEREAS, the Approved Budget for the Contract (ABC) is FIVE HUNDRED FIFTY EIGHT THOUSAND PESOS (Php558,000.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative methods of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) website, office website and conspicuous bulletin board in the premises of this Office on September 20, 2022 to September 26, 2022 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) M.I. SEVILLA RESORT; (2) OUANS WORTH FARM AND FAMILY RESORT CORPORATION; and (3) QUEEN MARGARETTE HOTEL;

WHEREAS, one (1) Supplier submitted its proposal; M.I. SEVILLA RESORT in the amount of FIVE HUNDRED TWENTY THOUSAND EIGHT HUNDRED PESOS (Php520,800.00). Thus, M.I. SEVILLA RESORT is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **M.I. SEVILLA RESORT** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);
