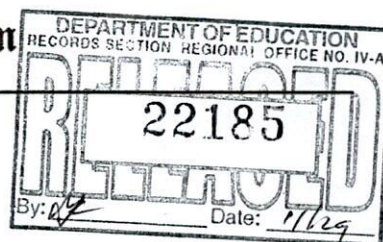

**WORKSHOP ON THE REVIEW AND ENHANCEMENT OF
COMPREHENSIVE SEXUALITY EDUCATION (CSE)
LEARNING RESOURCES**

To **Schools Division Superintendents** (SDO Cavite Province, SDO Rizal Province, SDO San Pedro City)

1. In reference to DM-OUCI-2022-294, the Department of Education (DepEd) through the Bureau of Curriculum (BCD) – in coordination with United Nations Population Fund (UNFPA), Center for Health Solutions and Innovations Philippines, Inc. (CHSI) and Commission of Population (POPCOM), shall conduct a **Workshop on the Review and Enhancement of Comprehensive Sexuality Education (CSE) Learning Resources** on December 5-9, 2022 at Whitewoods Hotel Silang, Cavite.
2. The activity aims to:
 - a. Review existing CSE materials;
 - b. Enhance the age- and developmental- appropriateness of CSE key messages integrated in the different learning areas;
 - c. Ensure alignment of integration with the revised basic education curriculum; and
 - d. Update the data on the 2021 Young Adult Fertility and Sexuality Study (YAFS5).

4. All participants are required to comply with the provisions directed in DepEd Order Nos. 43 & 46, s. 2022, also known as the **“Omnibus Travel Guidelines for All Personnel of the Department of Education.”**
