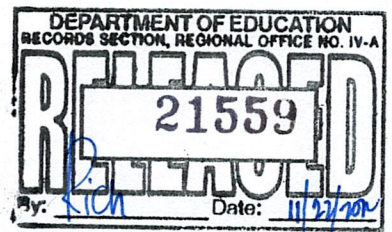



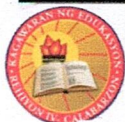
**REGIONAL MONITORING OF SPECIAL CURRICULAR

To **Schools Division Superintendents**

1. Pursuant to DepEd Order 34, s. 2022, DepEd Order 23, s. 2022, DepEd Order 22, s. 2018 this Office announces the conduct of the **Regional Monitoring of Special Curricular Program Implementing Schools and their Program Implementation** on November 28 and December 2, 2022.
2. As mandated, this activity aims to:
  - a. monitor the program implementation of SDOs implementing different SCPs;
  - b. give update on the utilization of fund of SCPs in the SDO;
  - c. provide technical assistance to SCP Implementers of the Schools Division Offices and Schools.
