## BAC RESOLUTION

**RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF  
CONTRACT TO FIRST STA. ROSA HOTEL CORPORATION – EL CIELITO  
HOTEL-STA. ROSA FOR THE PROCUREMENT OF FOOD AND  
ACCOMMODATION FOR THE DEVELOPING M&E TOOLS FOR LEARNING  
RECOVERY CONTINUITY PLAN (LRCP) ACTIVITIES (PHASE 1:  
CRAFTING/DEVELOPMENT)**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **DEVELOPING M&E TOOLS FOR LEARNING RECOVERY CONTINUITY PLAN (LRCP) ACTIVITIES (PHASE 1: CRAFTING/DEVELOPMENT)** on **NOVEMBER 8-10, 2022**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **TWO HUNDRED FIFTY-EIGHT THOUSAND PESOS (Php258,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the “Government Procurement Reform Act of 2003”, allows an agency to resort to Small Value Procurement as alternative methods of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex “H” thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on October 25, 2022 to November 2, 2022 at 9:00 a.m.

**WHEREAS**, RFQs were sent to five (5) prospective suppliers; The five (5) prospective suppliers are as follows: (1) BP MAKILING; (2) DEVELOPMENT ACADEMY OF THE PHILIPPINES (DAP); (3) EL CIELITO HOTEL – STA. ROSA; (4) THE BAYLEAF-CAVITE; and (5) CIUDAD CHRISTHIA RESORT, INC;

**WHEREAS**, five (5) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:


