WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **WORKSHOP ON THE QUALITY ASSURANCE OF SDO CONTEXTUALIZED LEARNING RESOURCES USED FOR LRP** on **NOVEMBER 23-25, 2022**;

WHEREAS, the Approved Budget for the Contract (ABC) is **FIVE HUNDRED NINETY-EIGHT THOUSAND PESOS (Php598,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative methods of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office on November 7, 2022 to November 11, 2022 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) THE BAYLEAF-CAVITE; (2) TANZA OASIS; and (3) WHITEWOODS CONVENTION AND LEISURE HOTEL;

WHEREAS, three (3) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:


