RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO SUNRISE RIDGE CORPORATION (SOLESTE SUITES) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE TARGET SETTING OF ADMINISTRATIVE SERVICES DIVISION PERSONNEL FY 2023

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the TARGET SETTING OF ADMINISTRATIVE SERVICES DIVISION PERSONNEL FY 2023 on DECEMBER 8-9, 2022;

WHEREAS, the Approved Budget for the Contract (ABC) is **ONE HUNDRED TWENTY THOUSAND (Php120,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office on November 22, 2022 to November 28, 2022 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) SUNRISE RIDGE CORPORATION (SOLESTE SUITES); (2) RED HOTEL; and (3) B HOTEL LEISURE CORPORATION;

WHEREAS, one (1) Supplier submitted its proposal; SUNRISE RIDGE CORPORATION (SOLESTE SUITES) in the amount of ONE HUNDRED NINETEEN THOUSAND SEVEN HUNDRED PESOS (Php119,700.00). Thus, SUNRISE RIDGE CORPORATION (SOLESTE SUITES) is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **SUNRISE RIDGE CORPORATION (SOLESTE SUITES)** in the amount of **ONE HUNDRED NINETEEN THOUSAND SEVEN HUNDRED PESOS** (**Php119,700.00**).
