

## REGIONAL OFFICE-SCHOOLS DIVISON OFFICE LEGAL COORDINATION AND MONITORING MEETING

### To SCHOOLS DIVISION SUPERINTENDENTS LEGAL UNIT PERSONNEL

- 1. To consistently enhance the coordination between the Legal Unit in the Schools Division Offices and Regional Office, the Legal Unit of this Office will be conducting the "Regional Office-Schools Division Office Legal Coordination and Monitoring Meeting" on **December 13 and 14, 2022**. This is in lieu of the "Bi-Annual Regional Office-Schools Division Office Legal Coordination and Monitoring Meeting," which was earlier scheduled on December 9, 2022, through the Regional Memorandum No. 22-321.
- 2. The venue of the "Regional Office-Schools Division Office Legal Coordination and Monitoring Meeting" will be announced in a separate Memorandum.
- 3. This activity will serve as an avenue for (a) monitoring and evaluation of administrative cases and other related concerns; (b) inquiries and discussions on certain legal matters brought to the attention of the Legal Unit; and (c) other related matters that will be brought out during the said activity.
- 4. In this regard, **all Attorney III and Legal Coordinators** in the Schools Division Offices are hereby ordered to attend the activity. Personnel of the Legal Unit of this Office are likewise ordered to attend.
- 5. For continuous discussion during the meeting, each SDO is required to prepare a 5-10 minutes power point presentation of the following:
  - a) annual accomplishment report of the SDO Legal Unit (2022);
  - b) no. of complaints pending investigation in the SDO;
  - c) no. of case/s pending formal investigation;
  - d) no. of schools with proof of ownership over school site; and
  - e) no. of schools without proof of ownership over school site and the ongoing action of the SDO on the matter.
