**RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO GOD'S TREASURE ENTERPRISES FOR THE PROCUREMENT OF CATERING SERVICES WITH STAGE DECORATION, LIGHTS AND SOUNDS AND TABLES AND CHAIRS FOR THE AWARDING CEREMONY OF THE PROGRAM ON WELFARE FOR EMPLOYEES OF THE REGIONAL OFFICE (POWER-O) ACTIVITIES**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES WITH STAGE DECORATION, LIGHTS AND SOUNDS AND TABLES AND CHAIRS** for the **AWARDING CEREMONY OF THE PROGRAM ON WELFARE FOR EMPLOYEES OF THE REGIONAL OFFICE (POWER-O) ACTIVITIES** on **DECEMBER 21, 2022**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **ONE HUNDRED EIGHTY-FIVE THOUSAND SIX HUNDRED PESOS (Php185,600.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on December 7, 2022 to December 13, 2022 at 9:00 a.m.

**WHEREAS**, RFQs were sent to four (4) prospective suppliers; The four (4) prospective suppliers are as follows: (1) GOD'S TREASURE ENTERPRISES; (2) ROSHER'S CATERING SERVICES; (3) FOCAL MANAGING LOOP INC.; and (4) BETTYLOVE CATERING;

**WHEREAS**, one (1) Supplier submitted its proposal; **GOD'S TREASURE ENTERPRISES** in the amount of **ONE HUNDRED EIGHTY-FIVE THOUSAND SIX HUNDRED PESOS (Php185,600.00)**. Thus, **GOD'S TREASURE ENTERPRISES** is declared as the lone bidder;

**WHEREAS**, after review and deliberation on the proposal, **GOD'S TREASURE ENTERPRISES** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);


