RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO FIRST PHILIPPINE REALTY CORP. – EUGENIO LOPEZ CENTER FOR THE PROCUREMENT OF MEALS, VENUE AND STAGE DECORATION FOR THE 2022 GAWAD BITUIN

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **MEALS, VENUE AND STAGE DECORATION** for the **2022 GAWAD BITUIN** on **JANUARY 13, 2023**;

WHEREAS, the Approved Budget for the Contract (ABC) is **THREE HUNDRED NINETY THOUSAND PESOS (Php390,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the “Government Procurement Reform Act of 2003”, allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex “H” thereof;


WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on December 15, 2022 to December 21, 2022 at 9:00 a.m.

WHEREAS, RFQs were sent to four (4) prospective suppliers; The four (4) prospective suppliers are as follows: (1) PHILIPPINE REALTY CORP. – EUGENIO LOPEZ CENTER; (2) FIRST PACIFIC LEADERSHIP ACADEMY; (3) LORELAND FARM RESORT and (4) MARCO POLO;

WHEREAS, one (1) Supplier submitted its proposal; **FIRST PHILIPPINE REALTY CORP. – EUGENIO LOPEZ CENTER** in the amount of **THREE HUNDRED NINETY THOUSAND PESOS (Php390,000.00)**. Thus, **FIRST PHILIPPINE REALTY CORP. – EUGENIO LOPEZ CENTER** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **FIRST PHILIPPINE REALTY CORP. – EUGENIO LOPEZ CENTER** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);


