**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **REGIONAL OFFICE-SCHOOLS DIVISION OFFICE LEGAL COORDINATION AND MONITORING MEETING** on **DECEMBER 13-14, 2022**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **ONE HUNDRED FORTY-FOUR THOUSAND PESOS (Php144,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

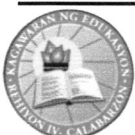
**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on December 5, 2022 to December 9, 2022 at 9:00 a.m.

**WHEREAS**, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) VILLA EXCELLANCE BEACH AND WAVEPOOL RESORT; (2) THE BAYLEAF CAVITE; and (3) TANZA OASIS HOTEL AND RESORT;

**WHEREAS**, one (1) Supplier submitted its proposal; **TAGAYTAY AUTO MART, INC. (TAGAYTAY COUNTRY HOTEL)** in the amount of **ONE HUNDRED FORTY THOUSAND FOUR HUNDRED PESOS (Php140,400.00)**. Thus, **TAGAYTAY AUTO MART, INC. (TAGAYTAY COUNTRY HOTEL)** is declared as the lone bidder;

**WHEREAS**, after review and deliberation on the proposal, **TAGAYTAY AUTO MART, INC. (TAGAYTAY COUNTRY HOTEL)** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);
