**RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO CALIV RESORT AND DEVELOPMENT CORP (VILLA EXCELLANCE BEACH AND WAVE POOL RESORT FOR THE PROCUREMENT OF LEASE OF VENUE WITH ACCOMMODATION AND MEALS FOR THE UPSKILLING OF REGION AND DIVISION READING SUPERVISORS/COORDINATORS ON THE EARLY LANGUAGE LITERACY AND NUMERACY (ELLN) WITH FOCUS ON THE SCIENCE OF READING (SOR)**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **LEASE OF VENUE WITH ACCOMMODATION AND MEALS** for the **UPSKILLING OF REGION AND DIVISION READING SUPERVISORS/COORDINATORS ON THE EARLY LANGUAGE LITERACY AND NUMERACY (ELLN) WITH FOCUS ON THE SCIENCE OF READING (SOR)** on **DECEMBER 12-18, 2022**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **ONE MILLION THIRTY-SIX THOUSAND PESOS (Php1,036,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office starting on November 18, 2022 to November 23, 2022 at 9:00 a.m.

**WHEREAS**, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) TANZA OASIS; (2) THE BAYLEAF-CAVITE; and (3) CALIV RESORT AND DEVELOPMENT CORP (VILLA EXCELLANCE BEACH AND WAVE POOL RESORT);

**WHEREAS**, one (1) Supplier submitted its proposal; **CALIV RESORT AND DEVELOPMENT CORP (VILLA EXCELLANCE BEACH AND WAVE POOL RESORT** in the amount of **NINE HUNDRED EIGHTY-FOUR THOUSAND TWO HUNDRED PESOS (Php984,200.00)**. Thus, **CALIV RESORT AND DEVELOPMENT CORP (VILLA EXCELLANCE BEACH AND WAVE POOL RESORT** is declared as the lone bidder;

**WHEREAS**, after review and deliberation on the proposal, **CALIV RESORT AND DEVELOPMENT CORP (VILLA EXCELLANCE BEACH AND WAVE POOL RESORT**


complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);


