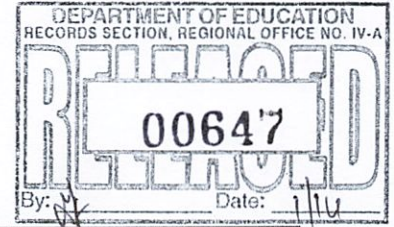

Other information indicated in RM 6 s. 2023 shall remain in effect.

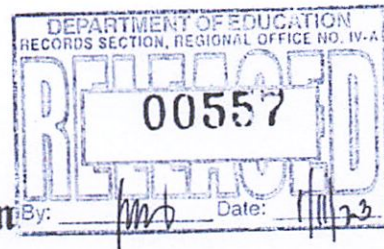


