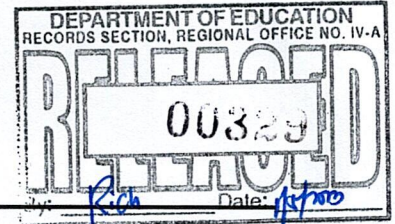

Expenses relative to the conduct of this activity shall be charged against Indigenous Peoples Education (IPEd) Program Support Fund 2022.

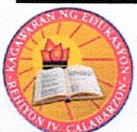
The Regional Monitoring Team is composed of CLMD Chief and CLMD Education Program Supervisors Focal Person of Special Curricular Programs.
