

### NEW DEADLINE FOR THE SUBMISSION TO DSWD OF THE REQUIRED CERTIFICATION FOR THE PANTAWID PAMILYANG PILIPINO PROGRAM (4Ps)

#### To Schools Division Superintendents

- Pursuant to OUGFO Memorandum No. 2022-03-3666 titled Updated Instruction on School Reporting for the Pantawid Pamilyang Pilipino Program (4Ps) (Annex A), this Office informs all concerned that per DepEd's coordination with the DSWD, the deadline for the submission of the required certification explained in the OUGFO memorandum has been moved from December 23, 202 to January 16, 2023.
- 2. This Office reiterates the importance of complying with the said certification and requests the full cooperation of all schools concerned, particularly those that were not able to submit Compliance Verification (CV) Forms for Compliance Period 5 of the 4Ps payment schedule (October-November 2022).
- 3. The certification, to be submitted in lieu of the CV forms, is necessary so that the 4Ps household beneficiaries will receive their educational cash grants for Compliance Period 5. 
