RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO DEPED REGION IV-A CALABARZON MULTIPURPOSE COOPERATIVE FOR THE PROCUREMENT OF CATERING SERVICES AT NEAP-RELC, MALVAR, BATANGAS FOR THE (A) VETTING AND FINALIZATION OF SCHOOL LEARNING ACTION CELL (SLAC) LEARNING RESOURCE PACKAGE (LRP) FOR LEARNING RECOVERY IN LITERACY AND NUMERACY and (B) ORIENTATION ON PUBIC SERVICE CONTINUITY PLANNING AND ENHANCEMENT OF CONTINGENCY PLANS

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES AT NEAP-RELC, MALVAR, BATANGAS** of the following:

- A. CATERING SERVICES AT NEAP-RELC, MALVAR, BATANGAS FOR THE VETTING AND FINALIZATION OF SCHOOL LEARNING ACTION CELL (SLAC) LEARNING RESOURCE PACKAGE (LRP) FOR LEARNING RECOVERY IN LITERACY AND NUMERACY on JANUARY 23-27, 2023;**
- B. ORIENTATION ON PUBIC SERVICE CONTINUITY PLANNING AND ENHANCEMENT OF CONTINGENCY PLANS on JANUARY 23-24, 2023;**

WHEREAS, the Approved Budget for the Contract (ABC) is **ONE HUNDRED EIGHTY THOUSAND PESOS (Php180,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on December 22, 2022 to December 28, 2022 at 9:00 a.m.

WHEREAS, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) MEDY'S CATERING SERVICES; (2) LUI BENG CATERING SERVICES; and (3) DEPED REGION IV-A CALABARZON MULTIPURPOSE COOPERATIVE;

WHEREAS, one (1) Supplier submitted its proposal; **DEPED REGION IV-A CALABARZON MULTIPURPOSE COOPERATIVE** in the amount of **ONE HUNDRED**


