WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of CATERING SERVICES AT NEAP-RELC, MALVAR, BATANGAS for the FINALIZATION OF IMPLEMENTING GUIDELINES ON THE REVIEWED GENDER-RELATED POLICIES IN DEPED on FEBRUARY 22-24, 2023;

WHEREAS, the Approved Budget for the Contract (ABC) is **SEVENTY-FIVE** THOUSAND SIX HUNDRED PESOS (Php75,600.00);

**WHEREAS,** Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS,** the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on January 26, 2023 to January 31, 2023 at 5:00 p.m.;

**WHEREAS,** RFQs were sent to four (4) prospective suppliers; The four (4) prospective suppliers are as follows: (1) DEPED Region IV-A CALABARZON Multipurpose Cooperative; (2) Louie and Chit Restaurant and Event Center; (3) Jun & Cristy Catering Services; and (4) Quizon's Catering Services;

**WHEREAS**, two (2) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:
