BAC RESOLUTION

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO GOD'S TREASURE ENTERPRISES FOR THE PROCUREMENT OF CATERING SERVICES FOR THE PLANTILLA AUDIT OF THE SCHOOLS DIVISION OFFICES AT DEPED CALABARZON

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **PLANTILLA AUDIT OF THE SCHOOLS DIVISION OFFICES AT DEPED CALABARZON** on **FEBRUARY 13-20, 2023**;

WHEREAS, the Approved Budget for the Contract (ABC) is **FIFTY-NINE THOUSAND FOUR HUNDRED PESOS (Php59,400.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on February 1, 2023 to February 6, 2023 at 9:00 a.m.

WHEREAS, RFQs were sent to four (4) prospective suppliers; The four (4) prospective suppliers are as follows: (1) DEPED Region IV-A CALABARZON Multipurpose Cooperative; (2) God's Treasure Enterprises; (3) Roshers Catering Services; and (4) Focal Managing Loop Inc.;

WHEREAS, one (1) Supplier submitted its proposal; **GOD'S TREASURE ENTERPRISES** in the amount of **FIFTY-SEVEN THOUSAND NINE HUNDRED FIFTEEN PESOS (Php57,915.00)**. Thus, **GOD'S TREASURE ENTERPRISES** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **GOD'S TREASURE ENTERPRISES** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **GOD'S TREASURE ENTERPRISES** in the amount **FIFTY-SEVEN THOUSAND NINE HUNDRED FIFTEEN PESOS (Php57,915.00)**.


