**BAC RESOLUTION**

**RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO FOCAL MANAGING LOOP INC. FOR THE PROCUREMENT OF CATERING SERVICES FOR THE QMS BENCHMARKING OF REGION VIII ON FEBRUARY 2-3, 2023 AT DEPED IV-A CAINTA, RIZAL**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **QMS BENCHMARKING OF REGION VIII AT DEPED IV-A CAINTA, RIZAL** on **FEBRUARY 2-3, 2023**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **FIFTY-SEVEN THOUSAND SIX HUNDRED PESOS (Php57,600.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

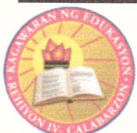
**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on January 26, 2023 to January 30, 2023 at 9:00 a.m.

**WHEREAS**, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) Focal Managing Loop Inc.; (2) Roshers Catering Services; and (3) 7Cs Catering Services;

**WHEREAS**, one (1) Supplier submitted its proposal; **FOCAL MANAGING LOOP INC.** in the amount of **FIFTY-FIVE THOUSAND SIX HUNDRED FORTY-EIGHT PESOS (Php55,648.00)**. Thus, **FOCAL MANAGING LOOP INC.** is declared as the lone bidder;

**WHEREAS**, after review and deliberation on the proposal, **FOCAL MANAGING LOOP INC.** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **FOCAL MANAGING LOOP INC.** in the amount **FIFTY-FIVE THOUSAND SIX HUNDRED FORTY-EIGHT PESOS (Php55,648.00)**.


