## BAC RESOLUTION

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO HAWKSTOW CONSTRUCTION AND DEVELOPMENT FOR THE PROCUREMENT OF REPAIR, IMPROVEMENT AND MAINTENANCE OF OFFICE BUILDINGS IN DEPED REGIONAL OFFICE IV-A LOT II

WHEREAS, on November 11, 2022, DepEd Regional Office IV-A CALABARZON has advertised its procurement activity for the REPAIR, IMPROVEMENT AND MAINTENANCE OF OFFICE BUILDINGS IN DEPED REGIONAL OFFICE IV-A LOT II in the PhilGEPS website, office website, and in conspicuous bulletin board of the office;

WHEREAS, the Approved Budget for the Contract (ABC) is THREE MILLION ONE HUNDRED NINETY-NINE THOUSAND ONE HUNDRED ELEVEN PESOS and 33/100 (PhP3,199,111.33);

WHEREAS, only one (1) bidder submitted its sealed bid at the Regional Office;

**WHEREAS,** using the checklist of required documents and taking into account the non-discretionary "Pass or Fail Criterion", the BAC found that the lone bidder, Hawkstow Construction and Development was eligible for being compliant with the required documents. Thus, Hawkstow Construction and Development was rated as "Passed";

WHEREAS, per Abstract of Bids, the lone bidder, Hawkstow Construction and Development has the Single Calculated Bid with a total amount of THREE MILLION ONE HUNDRED SIXTY-SEVEN THOUSAND PESOS (PHP3,167,000.00);

**WHEREAS**, upon Post-Qualification and careful examination, validation and verification of all the eligibility, legal, technical and financial requirements submitted by Hawkstow Construction and Development being the Single Calculated Bidder has been found to be responsive;

**NOW, THEREFORE**, pursuant to Implementing Rules and Regulations of RA 9184, the BAC hereby **RESOLVES**, as it hereby **RESOLVED**:

- 1. To DECLARE HAWKSTOW CONSTRUCTION AND DEVELOPMENT as the Single Calculated and Responsive Bidder in the amount of THREE MILLION ONE HUNDRED SIXTY-SEVEN THOUSAND PESOS (PHP3,167,000.00); and
- 2. To RECOMMEND to the Head of Procuring Entity the award of contract to HAWKSTOW CONSTRUCTION AND DEVELOPMENT for
