**RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO TAGAYTAY AUTO MART, INC. (TAGAYTAY COUNTRY HOTEL) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION, DECORATION INCLUDING LED BOARD, LIGHTS AND SOUND PACKAGE AND LIVE STREAMING PACKAGE FOR THE 2022 STAKEHOLDERS APPRECIATION AND SUMMIT AND 2022 NATIONAL LITERACY AWARDS**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION, DECORATION INCLUDING LED BOARD, LIGHTS AND SOUND PACKAGE AND LIVE STREAMING PACKAGE** for the **2022 STAKEHOLDERS APPRECIATION AND SUMMIT AND 2022 NATIONAL LITERACY AWARDS** on **JANUARY 9-10, 2023**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **THREE HUNDRED NINETY-TWO THOUSAND FIVE HUNDRED PESOS (Php392,500.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on December 21, 2022 to December 27, 2022 at 9:00 a.m.

**WHEREAS**, RFQs were sent to four (4) prospective suppliers; The four (4) prospective suppliers are as follows: (1) BAYLEAF CAVITE; (2) FIRST STA. ROSA HOTEL CORPORATION (EL CIELITO HOTEL – STA. ROSA); (3) TAGAYTAY AUTO MART, INC. (TAGAYTAY COUNTRY HOTEL) and (4) FOREST CREST NATURE HOTEL AND RESORT;

**WHEREAS**, two (2) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:


