BAC RESOLUTION

RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO HYPERNET – INTERNET & BUSINESS SOLUTIONS INC. FOR THE PROCUREMENT OF ICT INFRASTRUCTURE

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **ICT INFRASTRUCTURE**;

WHEREAS, the Approved Budget for the Contract (ABC) is **NINE HUNDRED SIXTY THOUSAND PESOS (Php960,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on December 19, 2022 to December 26, 2022 at 9:00 a.m.

WHEREAS, RFQs were sent to at least four (4) prospective suppliers; The three (3) prospective suppliers are as follows: (1) IP SOLUTION INC; (2) HYPERNET – INTERNET & BUSINESS SOLUTIONS INC.; (3) NETFRASYS; and (4) CLOUDBYTES;

WHEREAS, one (1) Supplier submitted its proposal; HYPERNET – INTERNET & BUSINESS SOLUTIONS INC. in the amount of NINE HUNDRED FIFTY-EIGHT THOUSAND NINE HUNDRED FIFTY PESOS (Php958,950.00). Thus, HYPERNET – INTERNET & BUSINESS SOLUTIONS INC. is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **HYPERNET – INTERNET** & **BUSINESS SOLUTIONS INC.** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **HYPERNET – INTERNET & BUSINESS SOLUTIONS INC.** in the amount **NINE HUNDRED FIFTY-EIGHT THOUSAND NINE HUNDRED FIFTY PESOS (Php958,950.00)**.
