**RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO LOUIE AND CHIT RESTAURANT AND EVENT CENTER FOR THE PROCUREMENT OF CATERING SERVICES AT NEAP-RELC, MALVAR, BATANGAS FOR THE CAPACITY BUILDING CUM WORKSHOP WITH SDO COUNTERPARTS ON PUBLIC AND PRIVATE SCHOOLS' PROCESSES (FIRST QUARTER)**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES AT NEAP-RELC, MALVAR, BATANGAS** for the **CAPACITY BUILDING CUM WORKSHOP WITH SDO COUNTERPARTS ON PUBLIC AND PRIVATE SCHOOLS' PROCESSES (FIRST QUARTER)** on **MARCH 2-3, 2023**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **FIFTY-FOUR THOUSAND TWO HUNDRED FIFTY PESOS (Php54,250.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on February 13, 2023 to February 17, 2023 at 9:00 a.m.;

**WHEREAS**, RFQs were sent to four (4) prospective suppliers; The four (4) prospective suppliers are as follows: (1) DEPED Region IV-A CALABARZON Multipurpose Cooperative; (2) Louie and Chit Restaurant and Event Center; (3) Jun & Cristy Catering Services; and (4) Quizon's Catering Services;

**WHEREAS**, one (1) Supplier submitted its proposal; **LOUIE AND CHIT RESTAURANT AND EVENT CENTER** in the amount of **FORTY-NINE THOUSAND PESOS (Php49,000.00)**. Thus, **LOUIE AND CHIT RESTAURANT AND EVENT CENTER** is declared as the lone bidder;

**WHEREAS**, after review and deliberation on the proposal, **LOUIE AND CHIT RESTAURANT AND EVENT CENTER** complied with the requirements and declared as the Single Calculated and Responsive Bid (SCRB);
