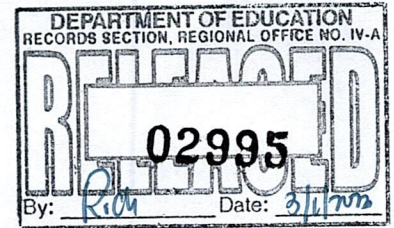

Other information indicated in RM 74 s. 2023 shall remain in effect.

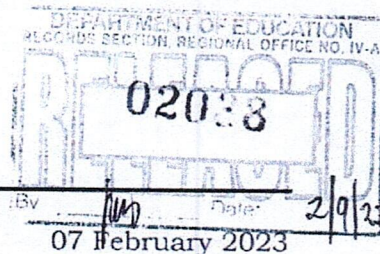


