**ONSITE HANYU SHUIPING KAOSHI EXAMINATION FOR
SPECIAL PROGRAM IN FOREIGN LANGUAGE-
CHINESE MANDARIN TEACHERS**

To **Schools Division Superintendents**
SDO Laguna and SDO Batangas Province

1. In reference with DM-Ct-2023-023, the Department of Education (DepEd), through the Bureau of Curriculum Development, in coordination with Confucius Institute at Angeles University Foundation (CI-AUF), will hold the **Onsite Hanyu Shuiping Kaoshi Examination for Special Program in Foreign Language-Chinese Mandarin Teachers** on **March 18, 2023, Saturday** at **Angeles University Foundation, Angeles City, Pampanga**.
2. This aims to further explore the opportunities and challenges faced in teaching Chinese as a foreign language and contribute to the enhancement of teachers' pedagogical skills.
3. Enclosure 1 presents the identified teachers taking Master of Arts in Education Major in Chinese Language who will undergo examination. They are part of the first batch of scholars for the SPFL-Chinese Mandarin.
4. The test fee will be shouldered by the CI-AUF. Meanwhile, the travel expenses shall be charged against the school MOOE, SEF, and/or other local funds available subject to usual accounting and auditing procedures.
5. The said activity is scheduled on a Saturday and thus avoids disruption of classes in adherence to the provisions of DepEd Order No. 34, s. 2022, titled School Calendar of Activities for School Year 2022-2023, DepEd DO 9, s. 2005 titled Instituting Measures to Increase Engaged Time-On-Tasks and Ensuring Compliance Therewith, and DepEd OASGFO Memorandum No. 2022-058 with the subject Request for the Participation of Learners and Teachers in Extra-Curricular Activities.
6. In addition, recognizing the efforts of the teachers, they are eligible to avail of service credits commensurate to the number of hours/ days of the training as scheduled, pursuant to DepEd Order No. 5, s. 2003 titled Updated Guidelines on Grant of Vacation Service Credits to Teachers.



