RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF CONTRACT TO LOUIE AND CHIT RESTAURANT AND EVENT CENTER FOR THE PROCUREMENT OF CATERING SERVICES AT NEAP-RELC, MALVAR, BATANGAS FOR THE ONE DAY REGION WIDE EXIT CONFERENCE

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES AT NEAP-RELC, MALVAR, BATANGAS** for the **ONE DAY REGION WIDE EXIT CONFERENCE** on **MARCH 23, 2023**;

WHEREAS, the Approved Budget for the Contract (ABC) is **SIXTY-EIGHT THOUSAND TWO HUNDRED FIFTY PESOS (Php68,250.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), office website and conspicuous bulletin board in the premises of this Office starting on March 8, 2023 to March 13, 2023 at 9:00 a.m.;

WHEREAS, RFQs were sent to at least three (3) prospective suppliers; The three (3) prospective suppliers are as follows: (1) Louie and Chit Restaurant and Event Center; (2) Jun & Cristy Catering Services; and (3) Quizon's Catering;

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of bids, offering the following financial bids, as read:

WHEREAS, upon evaluation of the BAC, the permit submitted by **JUN AND CRISTY CATERING SERVICE** is at Calapan, Oriental Mindoro. Considering the business address, it appears that **JUN AND CRISTY CATERING SERVICE** has no capacity to deliver the goods on time based on the needs of the procuring entity;


